The Diocese of Ohio has engaged actively in Becoming Beloved Community, providing resources and encouragement to congregations and diocesan entities (Bellwether Farm, Trinity Cathedral, committees, and commissions). The Diocesan Council has taken a principal lead in this work, studying The Episcopal Church's Racial Justice Audit, reading and discussing books (White Fragility, The Church Cracked Open, etc.), and inviting congregations to do the same. In sub-committees, it has focused on Penance, Reparations, Partnerships, Structure and Goals, and Council Needs. A recent issue of the diocesan quarterly, ChurchLife, was dedicated to racism awareness and racial equity. A Liturgy of Penance has been developed and used by the Council, and is being prepared for use in parishes and the Diocesan Convention. Members of the Diocesan and Cathedral staffs have participated in Sacred Ground, as have a number of congregations and leadership groups.
